The County wants to thank all of you for participating in our benefits survey and we want everyone to know this year we will be offering additional plans for the upcoming 2024 plan year.

It's time for you to begin thinking about your 2024 benefits choices. New Castle County conducts an annual open enrollment period during which benefits-eligible employees can enroll in, or make changes to, their benefits. Open enrollment for the 2024 plan year will begin on November 29, 2023, and will end on December 4, 2023.

What is Happening at Open Enrollment (Aetna Sessions)

Your 2024 Member Kit will arrive at your home by November 8th, to help you navigate through the process. It's important to take time to review your benefits and determine whether they still meet your needs and educate yourself on the additional value-added services built into each plan.

Exciting News for 2024....

- The County will continue to offer a plan that will be 100% paid for by the County on behalf of anyone who enrolls in that plan.
- The County will be adding a **NEW** hearing aid benefit to the plans. You'll have \$1,000 hearing aid reimbursement available once every 12 months.
- You will have the option to buy up to several other options for the upcoming year with enhanced benefits.
 - The County is offering 3 updated Rx options for the upcoming plan year.
 - The existing low Rx plan has had the \$260 deductible removed.
 - The new medium Rx plan has no deductible and provides for coverage in the Tier 1 and Tier 2 gap.
 - The existing high Rx plan no deductible and provides for full coverage in the gap.
- The County will be offering 2 medical plans, the Classic and the Preferred with several improved benefits.
 - A lower medical deductible
 - A lower inpatient hospital cost share
 - A lower specialist copay on the Preferred plan
 - A lower urgent care copay
- Please also remember you have four voluntary dental plans and a voluntary vision plan offered to you through the County each year during Open Enrollment.
